Long-term financing	Administrative fees: Up to QAR 2M (exempt from fees). Financing the above amount is subject to an Admin Fee of a maximum of 0.5% and a minimum of QAR 5000.
Short-term financing	Administrative fees: Up to QAR 2M (exempt from fees). Financing the above amount is subject to an Admin Fee of a maximum of 0.3% and a minimum of QAR 2500.

Administrative fees are due for preparing credit studies, feasibility studies, and the like, as well as organizing agreements, contracts, and documents. It is calculated on the total financing ceiling only once and is paid in advance upon signing the main agreement. It is also applied in cases of renewing or increasing the financing ceiling in exchange for actual expenses.
